- While shipping the camera, pack it in the factory packing or use materials with equivalent quality.
- If the product does not work properly, please contact your dealer or the nearest service center. Never attempt to disassemble or repair the product yourself in any way.
- with power adaptor over the rated voltage (5V); otherwise, the device may be damaged. [Notice] Never let any liquid flow into the camera. If any liquid enters the device by accident, pull out the battery

immediately. If the device is not used for a long time, take out the battery.

Use only the attached battery or battery and adaptor authenticated by this company. Never electrify the device

Do not expose the camera in the environment not defined in this Guide.

Do not use the device under temperature out of the specified range (-30 degree ~ 60 degree) or the battery may • be damaged. Never make the battery short circuit, decomposed or throw it into fire. Do not shield the heat dissipation part of the device.

[Notice] This device is equipped with replaceable battery and the design of the battery compartment is intrinsically safe. If installing a wrong model battery or the polarity is inversed, it may cause explosion

KEDACOM body worn camera DSJ-U1 reaches the industrial protection level IP67. If you want to open the battery cover, please keep the device dry and away from water or other liquids; when recovering the battery cover, make sure all sides are tightly locked; otherwise, its waterproofness may be affected.


III.Brief Introduction

Meeting GA/T947-2015 standard of the public security industry, DSJ-U1-LPN is a body worn camera for the policemen to record live video, take photos and record audio as evidences during law enforcement.


IV.Installation

Install Battery

The device is equipped with replaceable battery. When replacing the battery or not using the device for a long time, please pull out the battery. Open the back cover and pull out the battery as the following picture indicates.



Install SIM Card and TF Card



After pulling out the battery, insert Micro SIM/UIM card and TF card into the device. [Notice] Some models do not support SIM card slot. The method of installing a TF card is the same as that to install a Micro SIM/UIM card.


V. Appearance

[Indicators]

Normal: permanent green;

Recording video: constantly red;

Recording audio: constantly yellow



[Video Recording] Under the viewing mode, press it to start video Under video recording mode, re-press it to stop Support 180 degree vertical rotation. [Battery Indicator] Lack of voltage: the red flashes slowly; Charging: the red is on constantly; Full battery: the green is on constantly


[PTT] (push to talk) Press to talk: release to stop talking [Photograph] Under the viewing mode, press it to take a photo of current image in the viewing scene; Under the viewing mode, press it to start audio under the recording mode, press it to capture the image in the video record under audio recording mode, re-press it to finish audio recording and save it. [Power Supply] When the device is powered off, long-press on it for 3s to power on the device: when the device is powered on, long-press on it for 3s to power it off

> Under any mode, press IMP to trigger alarm snapshot (with alarm OSD). Under video or audio recording mode, press this button to mark the file as important one: under any mode, long-press on IMP for 3s and the LED lamp will be on to compensate light; long-press again for 3s and the LED lamp will be off

recording and save the video record.

[Volume Adjustment]

Press "+" or "-" to adjust volume.



VI.Interface Functions


Power on the device and enter the interface of viewing. Detailed operations can be referred to in *Body Worn Camera* DSJ-U1-LPN *User Manual*.




Appendix: Use of Charging Box and Charging Station

A body worn camera can be charged with either a charging box or a 6-set charging station together with other body worn cameras.

 When charging the battery of one body worn camera, only have to put the battery inside the charging box and connect the box to the power supplying device with USB wire.




Connect the charging box to the power supplying device with USB wire



Before charging multiple body worn cameras with the 6-set charging station, install the charging station and connect wires first, and then put the body worn cameras inside it.




Installation and Using of Charging Station


① Drill holes on the wall


③ Hang the charging station on the screws through the holes on its back and pull down the charging station to make it fixed.



② Insert the plastic expansion tubes into the holes and turn in the screws to fix them



Connect wires of the charging station, put the BWC inside the slot and turn on the general power supply to charge multiple BWCs simultaneously.
